3.1 GHG emission reduction measures implemented during the Reporting Period*

1.	CLP recently published the updated Climate Vision 2050, pledging not to invest in any additional coal-fired generation capacity and to progressively phase out all remaining coal assets by 2050. CLP continues to identify opportunities to accelerate the phase-out of coal from the CLP generation portfolio; and plans to increase our renewable energy capacity, and focus on opportunities in transmission and decentralised smart energy solutions. Furthermore, the Group committed to reviewing its targets no less than every five years.
2.	In Hong Kong, a new 550MW gas-fired generation unit at Black Point power station featuring combined cycle gas turbine (CCGT) technology is expected to be in operation in 2020. The new unit will assist Hong Kong in achieving the Government's target of increasing the share of gas to around 50% of the fuel mix by 2020. Another gas-fired unit of similar capacity is also planned for commissioning by 2023. The two units will contribute to the gradual phase-out of the oldest coal-fired units at Castle Peak Power Station which are expected to reach the end of their operating life in the mid-2020s.
3.	Construction of the largest landfill gas power generation system in Hong Kong at the West New Territories Landfill began in 2018. It would be in full operation in 2020 with generation capacity at 10MW. Subject to the availability of additional un-utilised landfill gas, expansion will be further assessed. Besides, The Clean Energy Transmission System connecting the CLP grid to Guangdong is planned to be strengthened by 2025, enhancing the accessibility to clean energy resources to help reduce fossil fuels use in Hong Kong.

¹ GHG emissions (direct and indirect) and removals in relation to the buildings can be broadly classified into three separate scopes as below –

- Scope 1 – direct emissions and removals;
- Scope 2 – energy indirect emissions; and
- Scope 3 – other indirect emissions.

The definitions of Scopes 1, 2 and 3 emissions can be found in the “Guidelines to Account for and Report on Greenhouse Gas Emissions and Removals for Buildings (Commercial, Residential or Institutional Purposes) in Hong Kong (2010 Edition)”

2 The reporting entity is encouraged to carry out verification of the GHG emissions by an independent verifier. Independent verification of GHG emissions can facilitate the management to have better understanding of the carbon footprint of the company's operation and identify areas for improvement, provide credibility and quality assurance on the disclosure of carbon footprint, and enhance the corporate image in respect of transparency and accountability. In December 2012, the Hong Kong Accreditation Service (HKAS) introduced accreditation service for ISO 14064 GHG validation and verification for validation/verification bodies' voluntary application. Accredited validation/verification bodies' technical competence is rigorously assessed by HKAS, so that the reliability of their results can be assured.
