1.	<p>Across the Group, we have implemented various energy saving technologies to reduce consumption of precious resources.</p> <p>In 2019, 22 hotels implemented centralised heat pumps that are three times more efficient at transferring energy than using boilers or heaters to generate heat, save energy around 39.6 GWh per year; 5 hotels installed vacuum boilers that are 15-30% more efficient than conventional steam and hot water boiler systems, estimated energy savings is 3.06 GWh per year; 29 hotels replaced their traditional light fittings to LED, and 53 hotels replaced showerhead in staff facilities which saves energy by reducing consumption of electricity for heating water, these technologies helped us to achieve estimated energy savings of 7.54 GWh per year.</p>
2.	<p>Reducing the temperature at which laundry is washed also has a considerable impact on energy use. In 2019 our low temperature laundry programme was implemented in 82 hotels, estimated annual energy savings is 39.69 GWh.</p> <p>Some hotels are producing renewable energy for hot water or electricity using photovoltaics.</p>
3.	<p>We invest in green buildings certified to local and international standards. This helps to ensure our new projects and renovations integrate sustainable design features, construction techniques and operational processes across the entire value chain in line with industry-best practices. In 2019, 36 of our hotels were certified Green Buildings, of which 17 hotels obtained Leadership in Energy and Environmental Design (LEED) certification from the United States Green Building Council, the most widely used green building rating system globally, and 19 hotels were certified under the other locally relevant schemes.</p>

² The reporting entity is encouraged to carry out verification of the GHG emissions by an independent verifier. Independent verification of GHG emissions can facilitate the management to have better understanding of the carbon footprint of the company’s operation and identify areas for improvement, provide credibility and quality assurance on the disclosure of carbon footprint, and enhance the corporate image in respect of transparency and accountability. In December 2012, the Hong Kong Accreditation Service (HKAS) introduced accreditation service for ISO 14064 GHG validation and verification for validation/verification bodies’ voluntary application. Accredited validation/verification bodies’ technical competence is rigorously assessed by HKAS, so that the reliability of their results can be assured.
