	Efficient Lighting: All new shops and office are now equipped with close to 100% LED or energy efficient lights
2	Charter on External Lighting: All relevant stores in HK are committed to switching off the lights at predetermined hours
3	Real time energy monitoring - our two stores in Temple Mall and Leung King Plaza participated in Link REIT's Tenant Energy Saving Pilot Programme, with a real time energy monitoring system installed. This allowed us to identify energy reduction potential, and promote energy saving and eco-friendly behaviour among frontline staff
4	Lights off: 50% of lights being mandatorily switched off during office lunch hours and during shop preparations hours
5	Zoning: Air conditioning and light zoning arrangements in offices to reduce unnecessary energy wastage
